REMINDER THAT THE ICT SECTOR COUNCIL (ICT COUNCIL) ANNUAL FEES 2023/24 (PERIOD 1ST MARCH 2023 TO 28 FEBRUARY 2024) ARE DUE ON OR BEFORE 01 DECEMBER 2024

Dear Sir/Madam,

This letter serves as a reminder that the ICT Council 2023/24 annual fees are due on or before 01 December 2024. ICT Measured Entities are required to confirm that ICT suppliers have contributed to the ICT Council Private Contribution Model.

The Private Sector Contribution Model is a mechanism to determine the value of contributions by ICT Measured Entities towards the funding of the operations of the ICT Council. The contribution model is calculated based on the annual turnover of the ICT Entity as determined in the B-BBEE verification certificate and or the B-BBEE Sworn Affidavit issued under the 2016 Amended ICT Sector Code.

Contributions paid to the ICT Council cannot also be claimed towards B-BBEE points under the 2016 Amended ICT Sector Code. The annual fees are due on or before 01 December 2024.

The annual fees for the financial year ending 2024 (1 March 2023 to 28 February 2024) are as follows.
